The JLOS Leadership Excellence Award (2017)

Awarded to **FRANCIS ATOKE** in recognition of his contribution to the Justice, Law and Order Sector as Solicitor General, Accounting Officer, and Chairperson of the JLOS Steering Committee. Mr. Atoke as Solicitor has been instrumental in driving the sector agenda through coordination of program management mechanisms at the JLOS Secretariat in his capacity as accounting officer of sector funds. As chairperson of the JLOS Steering Committee, Mr. Atoke continues to provide critical leadership to the JLOS strategic plan development process and a champion of results-based management.

Awarded to **CHARLES ELEM OGWAL** in recognition of his contribution to the Justice, Law and Order Sector as Deputy Director of Public Prosecutions and Chairperson of the JLOS Technical Committee. The JLOS Human Rights Defender Award (2017)

Awarded to **WINNIE ADUKULE** in recognition of her pro-bono legal aid services to juveniles in conflict with the law. Awarded to **FRANK BAINE MAYANJA** in recognition of his contribution to public and media engagement in the Uganda Prisons Service and the Justice, Law, and Order Sector. Frank is responsible for creating a powerful brand positive image of the Uganda

Prisons through sensitization of the public on Prison reforms; and for his pioneering work as a founding member of the JLOS Publicity and Media Committee

The JLOS Milestone Achievement Award (2017)

Awarded to the **COURTS OF JUDICATURE** in recognition of its record-breaking case backlog reduction rates in the FY 2016/17.

The Judiciary has over the years grappled with the challenge of case backlog due to various systemic challenges. However, in the FY 2016/17 the Judiciary owing to increased efforts and investments in the case backlog reduction program weeded out 175,000 cases in a record period of one year. This translated into a 24% reduction setting a record.

The JLOS Partnership and Collaboration Award (2017)

Awarded to **MAKERERE UNIVERSITY BUSINESS SCHOOL (MUBS)** in recognition of its contribution to prisoner education in the Uganda Prisons Service under the Prisons Rehabilitation Program. MUBS has long been associated with the award-winning prison rehabilitation program as a formidable partner to the Uganda Prisons Service.

MUBS has provided formal education services to prisoners by building skills that make inmates more productive people. Prisoners are given access to formal education under the national education structure, and in addition, are opportunities to acquire vocational skills that engage in income-generating activities.

The Justice, Law and Order Sector celebrates MUBS' strong partnership with prisoner reform efforts and giving hope to those within prison walls.

The JLOS DCC of the Year Award (2017)
